IGI and CEEC to Establish Congo School of Gemology

Industry and Congo-Area Leaders Conclude Initial Meeting to Kick-off Project

KINSHASA, Congo – The International Gemological Institute (IGI) today announced plans to establish a school of gemology in Kinshasa, following the December 13, 2010 signed agreement between IGI and the Centre of Expertise, Evaluation and Certification of Precious Minerals and Semi-precious Stones of Congo (CEEC) to initiate the project under the sponsorship of the European Union (EU), the Coordinator of the European Fund for Development (COFED) and the Platform for Governance Support (PAG).

The Democratic Republic of Congo is the second largest producer of diamonds in the world (source, Kimberley Process, 2009) and as such, there is a vital need for high-level professional gemological education. Project leaders from all affiliated organizations met to discuss initial plans earlier this month in Kinshasa.

"The establishment of a school of gemology is of paramount importance as it will provide the Congo diamond industry the necessary experts, professional support and instruction in order to contribute to improving the accuracy of the country's collection of mineral revenues, stated IGI CEO Roland Lorié.

After several months of preliminary training in Antwerp, IGI will deploy a group of experts to assist the CEEC under the guidance of the EU and the PAG. These representatives will utilize IGI methodology and establish several defined stages of preparation prior to the school's opening.
